SUBJECT: Nonrecurring Cost (NC) Recoupment Charge – MK97 Mod 0 Guidance Section (GS), MK89 Mod 0 GS and MK45 Mod 14 Target Detecting Device (TDD), DSCA Policy Memo 10-63

The attached Finding, signed by the Director, Defense Security Cooperation Agency, approves a nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.
