The attached Finding, signed by the Director, Defense Security Cooperation Agency, approves a NC recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.

DoD NC recoupment charges are required to be reimbursed to the Department of Defense within 30 days following delivery or purchaser acceptance (whichever comes first) of each item sold or produced; and all recoupments will be recorded under DSCA(Q) 1112 Report. In accordance with the Arms Export Control Act, any country requesting a waiver of NC charges must request the waiver in writing prior to finalization of the purchase, if it is to be approved. 
FINDING
