SUBJECT: Establish Nonrecurring Cost (NC) Recoupment Charge – Fuze, Artillery, Precision Guidance Kit (PGK), Department of Defense Acquisition Codes 1390-NA28 and 1390-NA29, DSCA Policy Memo 13-21

The attached Finding, signed by the Director, Defense Security Cooperation Agency, approves a nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.


FINDING
