SUBJECT: Establish Nonrecurring Cost (NC) Charge – Embedded Global Positioning System
(GPS)/Inertial Navigation System (INS) (EGI), DSCA Policy Memo 13-23

The attached Finding, signed by the Director, Defense Security Cooperation Agency (DSCA), approves a nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.
