SUBJECT: Establish U. S. Government and Special Nonrecurring Cost (NC) Charges – Radar,
Scalable Agile Beam Radar (SABR), AN/APG-83 AESA, DSCA Policy 15-28

The attached Finding, signed by the Director, Defense Security Cooperation Agency (DSCA), approves United States Government and special NC recoupment pro rata charges for the sale, coproduction, or licensed production of the item shown on the Finding table.
