SUBJECT: Establish Nonrecurring Cost (NC) Charges for Joint Air-to-Surface Standoff
Missiles (JASSM) and Test Instrumentation Kits (TIK), DSCA Policy 15-31

The attached Finding, signed by the Director, Defense Security Cooperation Agency (DSCA), approves NC recoupment pro rata charges for the sale, coproduction, or licensed production of the items shown on the Finding table.
