**SUBJECT:** Assignment of Program Code "Q5" to Track Fiscal Year (FY) 2015 Funds Provided for Global Peacekeeping Operations Initiative (GPOI), DSCA Policy 15-32 [SAMM E-Change 279]

Effective immediately, Program Code "Q5" is assigned to track and execute FY15 funds provided for GPOI. Division J of the Consolidated and Further Continuing Appropriations Act, 2015 provides funding for this authority through September 30, 2019 if initially obligated before September 30, 2015. Management and execution of FY15 GPOI (Q5) programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.
