Security Assistance Management Manual (SAMM), E-Change 273 Administrative Changes

1. Table C11.T6. summarizes legislation associated with Excess Defense Articles (EDA). <u>PL113-276</u> amended FAA Section 516(g) (22 U.S.C. 2321j) to increase the limit of aggregate current market value of grant EDA to \$500,000,000 from \$425,000,000 in any single fiscal year. Table C7.T6., should be amended to read:

- 2. Figure C5.F6. provides instructions for preparing a Letter of Offer and Acceptance (LOA). All references to "country" should be replaced with "Security Cooperation Customer".
- 3. Taiwan requested to extend the Offer Expiration Date for LOAs to 120 days. Insert the following line into C5.F6.5.

- 4. Delete "FOB-Destination" from Table C9.T4a in the descriptions of "Delivery Term Codes".
- 5. The "Principles of Use of Military Unmanned Aerial Systems (UASs) or Strike-Enabling Technologies to be Used on UASs" case notes in Appendix 6 are revised with the addition of the following as the final paragraph in the Note Usage section of both notes:

"It is the responsibility of the Implementing Agency to identify in the line description note that the UAS in question is a military UAS, one controlled under the ITAR whether armed or unarmed, and whether a strike-enabling technology is intended for use on a UAS of any type."

6. Restore to Appendix 6 the note for "Global Positioning System (GPS)/Precise Positioning System (PPS) Security Devices Sold FMS for Integration Into Host Application Equipment," which was inadvertently deleted in Admin Change Memo DSCA 15-13.
