SUBJECT: Assignment of Program Code "P7" to track Fiscal Year (FY) 2016 Funds Provided for Peacekeeping Operations (PKO), Overseas Contingency Operations (OCO), DSCA Policy 16-28 [SAMM E-Change 312]

Effective immediately, Program Code "P7" is assigned to track and execute FY 2016 funds provided for PKO/OCO. Division K, Title I, Consolidated Appropriations Act, 2016 (P.L. 114-113) provides funding for this authority through September 30, 2021. Management and execution of FY 2016 PKO (P7) programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2, Country and International Organization Codes and FMS Eligibility, is updated as follows:
