SUBJECT: Assignment of Program Code "7D" to Track Fiscal Year (FY) 2017/18 DSCA Operation and Maintenance Funds Executed Pursuant to Section 333 Build the Capacity of Foreign Security Forces Program, DSCA Policy 17-42 [SAMM E-Change 372]

Effective immediately, Program Code "7D" is assigned to track FY 2017/18 Operation and Maintenance (O&M) funds provided to DSCA in Division C of the Consolidated Appropriations Act, FY 2017, to be executed under the authority of section 333 of title 10, United States Code. Funds are available to conduct or support a program or programs under the section 333 authority through September 30, 2018. Management and execution of FY 2017/18 (7D) programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.
