Effective immediately, Program Code "7U" is assigned to track FY 2018/2019 Defensewide Operation and Maintenance appropriated funds for the Coalition Readiness Support Program (CRSP) Program. Funds are provided under Division C Bipartisan Budget Act of 2018" (P.L. 115-123) and will remain available for obligation until September 30, 2019. Management and execution of FY 2018/2019 "7U" programs must comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2B, Security Cooperation (SC) Customer and Regional Codes and FMS Eligibility, is updated as follows:
