Request your organization ensure that the FMS system(s) you maintain are updated to reflect this revised information. Likewise, DSCA will ensure that DSAMS is updated as appropriate. For the countries/entities shown above, request DFAS transfer all cases already closed directly from 'C1' (non-participant) to 'C3' (ACCP final) status.

Attached is a master roster of all ACCP participants. Wide dissemination of this roster is highly encouraged. *Reference (b) is hereby superseded.* Table C4.T2 of the Security Assistance Management Manual will be revised to reflect the change in ACCP status for both UK and M6.
