
Effective immediately, SAMM Table C4.T2., Country and International Organization Codes and FMS Eligibility, is updated to add the codes "Y5" and "Y6" to track funds provided under Section 9006 of FY05 Defense Appropriations Act (Public Law 108-287) for Afghanistan (Y5)

and for Iraq (Y6). The Defense Security Cooperation Agency must authorize use of this code for Letters of Offer and Acceptance documents.
