**SUBJECT: Letter of Offer and Acceptance (LOA) Distribution for U.S. Central Command (CENTCOM) (DSCA Policy 07-41)**

As a means of increasing CENTCOM's visibility over its security cooperation programs, CENTCOM J4 has asked to be on distribution for all LOAs, Amendments, and Modifications destined for FMS countries within its Area of Responsibility (AOR): Afghanistan, Bahrain, Djibouti, Egypt, Eritrea, Ethiopia, Iran, Iraq, Jordan, Kazakhstan, Kenya, Kuwait, Kyrgyzstan, Lebanon, Oman, Pakistan, Qatar, Saudi Arabia, Seychelles, Somalia, Sudan, Syria, Tajikistan, Turkmenistan, United Arab Emirates, Uzbekistan, and Yemen.

Effective immediately, Implementing Agencies shall send copies of all these documents to CENTCOM J4 simultaneously with providing: 1) the LOA or Amendment to the FMS purchaser to accept, or 2) the Modification to the FMS purchaser to acknowledge receipt. Non-FMS ("pseudo") documents may be sent after DSCA acceptance/signature.


