### FINDING

In accordance with DoD Directive 2140.2, dated January 13, 1993, I hereby eliminate the nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the following items:

#### CATEGORY XI, MILITARY AND SPACE ELECTRONICS

ITEM DESCRIPTION
Radio, AN/VRC-89E SINCGARS MASL: 5820000VRC89E
Radio, AN/VRC-91E SINCGARS MASL: 5820000VRC91E
Radio, AN/VRC-92E SINCGARS MASL: 5820000VRC92E

The above items are re-categorized from major defense equipment (MDE) to significant military equipment (SME), the NC recoupment charges of \$1,606 are eliminated, and DSCA Policy Memo 09-19 is rescinded.
