SUBJECT: Establish Nonrecurring Cost (NC) Recoupment Charge – Patriot Launching Station,

The attached Finding, signed by the Director, Defense Security Cooperation Agency, approves a nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.
