SUBJECT: Establish Nonrecurring Cost (NC) Charge – MQ-4C Triton Unmanned Air Vehicle,
Ground Control Station (GCS) and Radar, DSCA Policy Memo 13-50

The attached Finding, signed by the Director, Defense Security Cooperation Agency (DSCA), approves a NC recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.


FINDING
