SUBJECT: Assignment of Program Codes “P4” to track Fiscal Year (FY) 2014 Funds Provided for Peacekeeping Operations (PKO) and “J6” to track (FY) 2014 Funds Provided for Coalition Readiness Support Program (CRSP), DSCA Policy 14-04, [SAMM E-Change 247]

Effective immediately, Program Code “P4” is assigned to track and execute FY14 funds provided for PKO and Program Code “J6” is assigned to track and execute FY 14 funds provided for CRSP. The management and execution of these programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

FY14 funds expire for new obligations in compliance with the terms of the appropriation authority. All projects must be completed before the funds' cancellation date.
