SUBJECT: Assignment of Program Code "J7" to track Fiscal Year (FY) 2015 Funds Provided for the Section 1206 Global Train and Equip Programs, DSCA Policy 14-25 [SAMM E-Change 261]

Effective immediately, Program Code "J7" is assigned to track FY15 funds provided for Section 1206 programs. The National Defense Authorizations Act for Fiscal Year 2014 (Public Law 113-66), Section 1201(e) amended subsection (g) of Section 1206 of the NDAA for Fiscal Year 2006 to extend the authority through September 30, 2017. Management and execution of FY15 Section 1206 (J7) programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2, Country and International Organization Codes and FMS Eligibility, is updated as follows:

Government and contract services under a Section 1206 Program are provided with “cross fiscal year authority” as described in the SAMM, Chapter 15, C15.3.4.3. Funding associated with J7 LOAs will be fully expended, and J7 cases will be reconciled and closed two months before fund cancellation date.
