SUBJECT: Assignment of Program Code "2G" to track Fiscal Year (FY) 2016/2017 Pakistan Stability Operations Fund (PSOF), DSCA Policy 17-28 [SAMM E-Change 360]

Effective immediately, Program Code "2G" is assigned to track FY 2016/17 Pakistan Stability Operations Funds (PSOF) programs. Funds are provided by Division C of the Consolidated Appropriations Act, 2016 and are available for obligation until September 30, 2017. Management and execution of FY 2017 PSOF programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2, Country and International Organization Codes and FMS Eligibility, is updated as follows:
