## Security Assistance Management Manual (SAMM), E-Change 407 Administrative Changes

- C9.14.2. Business Process Reviews.
  - o C9.14.2. Business Process Reviews (BPRs).
- C9.14.2.4. Deliverables. DSCA (Directorate of Business Operations (DBO)) will prepare minutes from the BPRs, to include any action items, and provide to the participants. Further, it will track actions and follow-up to ensure all open action items are completed.
  - O C9.14.2.4. Deliverables. DSCA (Directorate of Business Operations (DBO)) will prepare minutes from the BPRs, to include any action items, and provide to the participants no later than 20 days after completion of the BPR. Further, DBO will track the status of action items and follow-up every 30 days until all open action items are completed.
- C3.3.4.2. ".... ITAR Form DSP-85 is required for any import and re-export from the United States of classified defense articles being temporarily imported into the United States."
  - C3.3.4.2. ".... An ITAR Form DSP-85 is required for any import and re-export from the United States of classified defense articles being temporarily imported into the United States that are not otherwise exempted by 22 CFR 123.4 (a) (5) and 126.6 (c)."

- C10.6.3.4. ".... IMET funds may be used for a maximum of two IMS to obtain a postgraduate degree at non-invitational PME schools, e.g. the U.S. Naval Postgraduate School or at the Air Force Institute of Technology with the approval of State PM/SA."
  - C10.6.3.4. ".... IMET funds may be used for a maximum of two IMS to obtain a
    postgraduate degree at non- PME/E-IMET schools with the approval of State
    PM/SA."
- C10.T5. ".... For example, SCOs should include no more than five of the same technical course, no more than ten of the same PME course in their IMET program, and no more than two master's degree courses (excluding invitational PME courses), per fiscal year. (Note: All requests for IMET funded Master's degree programs require DoS (PM/SA) approval.)"
