SUBJECT: Assignment of Program Code "Q9" to track Global Peace Operations Initiative (GPOI) funds for Fiscal Year (FY) 2019 GPOI, DSCA Policy 19-57 [SAMM E-Change 460]

Effective immediately program code "Q9" is assigned to track FY 2019 funds provided for the Global Peace Operations Initiative (GPOI). Funds were provided by Division F of the Consolidated Appropriations Act, 2019 (P.L.116-6) and obligated via transfer from the Department of State to the Defense Security Cooperation Agency via signature of a Memorandum of Agreement pursuant to section 63 2(b) of the Foreign Assistance Act of 1961, as amended, on September 30, 2019. Funds are available for reprogramming and expenditure until September 30, 2023.

Instructions for preparation of "Q9" LOA documents are found in the SAMM, Table C15.T5. Standard notes applicable to BPC programs are found in the SAMM, Appendix 6, LOA Notes Listing. Funding associated with "Q9" LOAs will be fully expended and "Q9" cases will be reconciled and closed two months before the funds cancellation date.
