SUBJECT: Update of Program Code "C5" to track Fiscal Year (FY) 2020 Afghanistan Security Forces Fund (ASFF) Country Contribution (CTRB) Programs, DSCA Policy 20-21 [SAMM E-Change 473]

Effective immediately, Program Code "C5" is assigned to track FY 2020 partner contributions to the Afghanistan Security Forces Fund (ASFF) that will be used to provide assistance to the security forces of Afghanistan. Funds provided to support "C5" programs will remain available until expended.

Management and execution of FY 2020 ASFF (C5) programs will comply with guidance provided in the SAMM, Chapter 15. Instructions for preparation of C5 LOA documents are found in the SAMM, Table C15.T5. Standard notes applicable to BPC programs are found in the SAMM, Appendix 6, LOA Notes Listing. Funding associated with C5 LOAs will be fully expended and C5 cases will be reconciled and closed two months before the funds cancellation date.
