SUBJECT: Defense Security Cooperation Policy Memorandum 24-84, Assignment of Semi-Permanent Program Codes "UW," "UX," "VW," and "VX" for Counter-ISIL Train and Equip Funding, to Track Funding Beginning in Fiscal Years 24/25 to Support the Building Partner Capacity Long Term Solution [SAMM E-Change 727]

Reference: Building Partner Capacity Funds Return Guidance, DSCA Policy Memo 22-33

The semi-permanent program codes "UW" are assigned to track funds under the authority Counter-ISIL Train and Equip Funding (CTEF) for Iraq and "VW" under the authority of CTEF for Syria. Program codes "UX" for CTEF for Iraq and "VX" for CTEF for Syria are assigned for the same purposes for use when Case Designators for "UW" and "VW" are exhausted. The program codes support the Building Partner Capacity Long Term Solution. Additionally, P.L. 118-47, Further Consolidated Appropriations Act, 2024, Division A, authorizes two-year Operations and Maintenance funding for CTEF. The policy in the attachment is incorporated into the DSCA Security Assistance Management Manual (SAMM) at https://samm.dsca.mil.

This memo also rescinds DSCA Policy Memos <u>23-72</u> and <u>24-69</u> and deletes information in C4.T2. and AP8.T2. for Program Codes "EY" and "QR."

Instructions for preparation of "UW," "UX," "VW," and "VX" Letter of Offer and Acceptance (LOA) documents will be provided along with the rest of the Building Partner Capacity Long Term Solution Guidance. Standard notes applicable to Building Partner Capacity (BPC) programs are found in the Appendix 6, LOA Notes Listing. Funding associated with

"UW," "UX," "VW," and "VX" LOAs will be fully expended, and cases will be reconciled and closed in accordance with DSCA <u>Policy Memo 22-33</u>, Building Partner Capacity Funds Return Guidance.
