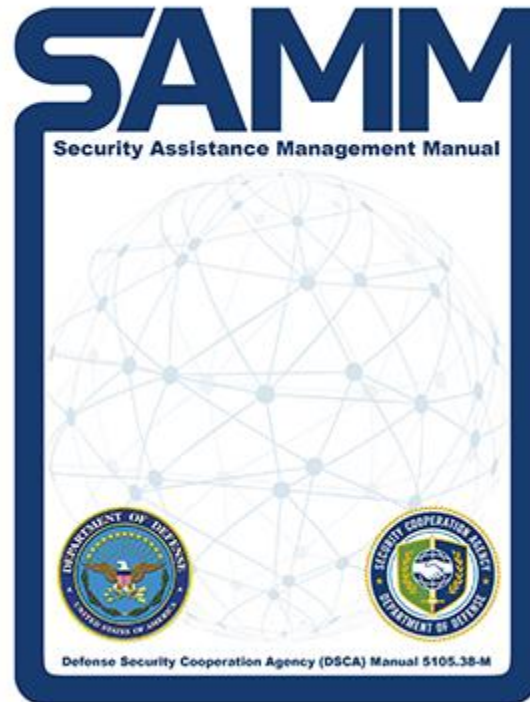
SUBJECT: Defense Security Cooperation Agency Policy Memorandum 25-40, Addition of
