SUBJECT: Defense Security Cooperation Agency Policy Memorandum 25-86, Updates to Generic Codes in Appendix 4 [SAMM E-Change 783]

This memorandum updates Generic Codes in Appendix 4 of the Security Assistance Management Manual (SAMM) for synchronization of information within the Defense Security Assistance Management System and for improved categorization of defense articles and services provided on cases. Generic Codes are three-character codes assigned to every Military Articles and Services List (MASL) to organize defense articles and services for reporting purposes. The Implementing Agencies select the appropriate Generic Code when requesting new MASLs or updates to MASLs to DSCA.
