This memorandum establishes a new CLOSHOLD milestone within the Defense Security Assistance Management System (DSAMS) to prevent the creation of new amendments, modifications, and/or revisions to cases that have been moved to final closure or are in the process of final reconciliation for closure. The creation and use of this milestone is effective immediately and intended to align with the prioritization of Foreign Military Sales (FMS) case closure activities outlined in reference (a).

The Defense Security Cooperation Agency (DSCA) Office of Business Operations, Financial Policy & Regional Execution Directorate will apply the CLOSHOLD milestone to FMS cases that are Supply/Services Complete (SSC) to ensure no additional changes are made to the case in DSAMS. The creation of this milestone is intended to improve the case closure process and ensure cases are closed efficiently. The milestone also enables DSCA to better

capture case closure metrics and ensure alignment with policy regarding FMS case reconciliation and closure.
