SUBJECT: Assignment of Program Code "Z8" to track Fiscal Year (FY) 2017 Ukraine Security Assistance Initiative, DSCA Policy 17-21 [SAMM E-Change 357]

Effective immediately, Program Code "Z8" is assigned to track FY 2017 Ukraine Security Assistance Initiative (USAI) programs. Funds are provided by Division C of the Consolidated Appropriations Act, 2017 and are available for obligation until September 30, 2017. Management and execution of FY 2017 USAI programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2, Country and International Organization Codes and FMS Eligibility, is updated as follows:
